I understand that these risks include, but are not limited to, the following: (1) Climbing equipment, bolts and other fixed protection have limitations and are subject to failure. (2) Improper use of protection devices or climbing equipment can result in injury or death. (3) Improper belay, rappel, or climbing technique can result in injury to you or to others.

I understand and accept that the organizers and sponsors of this event are not responsible for the natural or man-made conditions at Enchanted Rock or the equipment that I use; nor are they responsible for determining whether or not I possess the necessary training or experience to climb safely.

WARNING OF RISK and RELEASE OF LIABILITY

I also understand that I am not entitled to a rescue if I am injured, that rescue may not be available, and that even if available, rescue attempts may fail. I understand that there are more hazards than are enumerated here, including unknown and unforeseeable hazards.

I PARTICIPATE IN THIS EVENT WITH FULL KNOWLEDGE OF THE INHERENT RISKS OF INJURY OR DEATH THAT MAY RESULT. I AGREE TO CLIMB AT MY OWN RISK.

In consideration for my entry in this climbing competition, I, for myself, my heirs, successors and representatives, hereby knowingly and intentionally **WAIVE, RELEASE AND DISCHARGE, AND AGREE TO INDEMNIFY, HOLD HARMLESS, AND DEFEND** the Texas Parks and Wildlife Department, the Central Texas Climbing Committee, Friends of Enchanted Rock SNA, and the organizers and sponsors of this event, from any and all liability, responsibility, actions, causes of action, claims or demands for, upon, or by reason of any damage, loss or injury, resulting from, or in any way connected with my participation in this event. I explicitly agree that this release and indemnification extends to harm resulting from any **NEGLIGENCE** of these parties, as well as any **RECKLESS** failure of these parties to guard or warn against known dangerous conditions.

I further agree, for myself, my successors and heirs not to sue the organizers or sponsors of this event, their family members, agents, employees or representatives, for any injuries that I incur in connection with my participation in this competition.

This agreement and release is severable and if any part of it is held by a court of law to be unenforceable, the rest of it shall nevertheless be effective.
